##### *The service:*

This is an ADSL2+ broadband service offering fast speed internet access via AAPT network with a monthly included data allowance mentioned below. Once the data limit is reached, the speed will be shaped to 64Kbps.

##### *Bundling:*

You must have a dedicated phone line for this service to work. This service is not conditional on you having a phone line with us and equally the phone line rental is not included in the service. Please contact us if you wish to have a service that also includes a phone line with us.

If you cancel your service prior to the end of your contract term you will incur early termination charges. Termination charges are \$0 for 1 month, \$100 for 12 months and \$165 for 24 months contract. The service is linked with premises as well as the service number. Termination will result in case of either changing the land line number at the same premises or changing address with the same land line number.
